("THE REGULATIONS")**

**INSTRUMENT OF GOVERNMENT
FOR A FEDERATED GOVERNING BODY**

1. The name of the federation is: **Tibberton CE & St Lawrence CE Primary School**
2. The names and categories of the schools in the federation are:

Tibberton CE Primary School	Voluntary Controlled
St Lawrence CE Primary School	Voluntary Controlled
3. The name of the governing body is: **Tibberton CE & St Lawrence CE Primary Federation**
4. The governing body shall consist of:
 - (a) **2** Parent governors (one from each school);
 - (b) **1** LA governor;
 - (c) **2** Staff governors (Headteacher included);
 - (d) **3** Foundation governors (at least one from each school);
 - (e) **5** Co-opted governors
5. Total number of governors **13**
6. Term of office for all governors is **4 years**
7. The name of the foundation body entitled to appoint foundation governors is:-
The Lichfield Diocesan Board of Education
8.
 - a) The holders of the following offices shall be foundation governor ex-officio:
The Principal Officiating Minister of the Parish of Tibberton and The Principal Officiating Minister Parish of Preston Upon the Wealdmoors
 - b) The **Archdeacon of Salop** shall be entitled to appoint a foundation governor to act in the place of the ex-officio foundation governor, whose governorship derives from the office named in (a) above, in the event that the ex officio foundation governor, is unable or unwilling to act as a foundation governor, or has been removed from office under regulation 24 (2) of the Constitution Regulations.
9. The name of the person entitled to request the removal of the ex-officio foundation governor and to appoint any substitute governor is:- **The Archdeacon of Salop**
10. The following trust in accordance with the provisions of which the school shall be conducted, exists in relation to the school:

Tibberton CE Primary : The religious character of the school is set out in a conveyance of 26 May 1921 between the Earl of Sutherland and the Duke of Argyll and the Vicar and Church Wardens of the Parish of Tibberton and was confirmed by a conveyance of 26 May 1971 between the County Council of Salop and the Vicar and Church Wardens.

St Lawrence CE Primary: the school was established as a church school by a conveyance of the 4th March 1989 by the Earl of Bradford and others in favour of the Minister and Churchwardens of the Parish of Preston on the Wealdmoors. The Minister and Churchwardens of the Parish of Preston Wealdmoors are the trustees of the school.

11. The religious ethos of the school is as follows:-

Recognising its historic foundation, the schools will preserve and develop its religious character in accordance with the principles of the Church of England and in partnership with the Church at parish and diocesan level.

The schools aim to serve its community by providing an education of the highest quality within the context of Christian belief and practice. It encourages an understanding of the meaning and significance of faith, and promotes Christian values through the experience it offers to all its pupils.

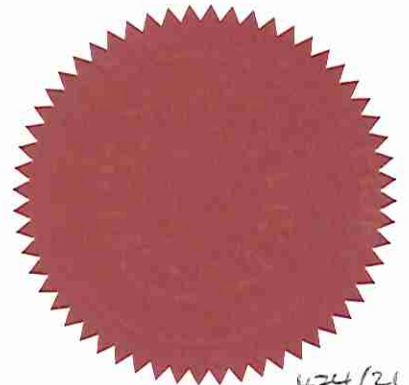
